### OSRO/EPA Region IV Meeting

In February, Matt Skinner attended the Coast Guard National Strike Force/ EPA Region IV meeting in South Carolina. Approximately 125 federal and state emergency managers were present. Marion was the only private sector contractor present, which is unusual. FEMA, state EMA representatives, the Coast Guard, NOAH, EPA Region IV, and On Scene Coordinators all attended. Matt had the opportunity to field questions related to contractor policy when working with state and federal agencies. These meetings are designed to gauge each individual state's resources and the overall ability of the region to respond to large scale releases and natural disasters. Additional budget cuts have resulted in the loss of key personnel and equipment that has left no state unaffected. The opinion among many of the esteemed assembly was that a general shift towards the private sector and the OSRO program was eminent.
