Continued from page 1 – Review of Solid Haz Waste Conference:

December 1<sup>st</sup>, 2013 is the training deadline for the Revised Hazard Communication Standard. The Occupational Safety and Administration (OSHA) revised communication standard (HCS) to align with United Nations Globally Harmonized System of Classification and Labeling of Chemicals (GHS). Two significant changes contained in the revised standard require the use of new labeling elements in a standardized format for Safety Data Sheets (SDS) formerly known as Material Safety Data Sheets (MSDS). OSHA believes that the new label elements and SDS requirements will improve worker understanding of the hazards associated with chemicals in the workplace. To help employers comply with the revised standard; OSHA is phasing in the specific requirements over several years from December 1, 2013 to June 1, 2016. The first compliance date of the revised HCS is December 1, 2013, by that time employers **must** train their workers on the new label elements in the SDS format. This training is needed early in the transition process since workers are already beginning to see the new labels and SDS's in the workplace. Remember, according to OSHA, for training to be considered accomplished the name of the employee and the date of training must be recorded and filed.

Also of interest is the formation by TDEC of a regional office for external affairs. The Chattanooga Regional Director for External Affairs is Tyler T. Jeffrey M.S.G.S. If any entity needs help or direction in working with TDEC, Ms. Jeffrey is now considered "point of first contact" in the Chattanooga Region. MEI recently met with Ms. Jeffrey as she began an introductory tour designed to educate private business in the mission of External Affairs. MEI highly recommends that anyone needing help navigating the complex system of TDEC offices, departments, and Divisions give Ms. Jeffrey a call at her office.
